Groundhog Day

In February, Pennsylvania becomes the fake meteorology capitol of the world. People travel up and down and over and around to arrive at Gobbler's Knob in Punxsutawney. They gather on February 2 to hear the prognostication of Phil, the world's most famous groundhog. He tells us whether we're going to have six more weeks of winter or not.

It's truly amazing that people care so much for this, but they do. In some years the average price for a hotel room in Punxsutawney on Groundhog Day has been higher than the average price for a hotel room for the Super Bowl.

One of the things spinning out of this fascination with alternative meteorology was the 1993 film, *Groundhog Day,* starring Bill Murray and Andie McDowell. In it, Bill Murray plays Phil Connors, a cynical, self-absorbed weatherman from Pittsburgh, who comes to Punxsutawney to cover the event. He wakes up the next day to find out it's not the next day at all – it's Groundhog Day all over again. And the next day and the next day and the next day... He can't escape to tomorrow. He's stuck in Groundhog Day.

First, realizing that he will suffer no ongoing consequences if he does so, he indulges as many different fantasies as he can in these ultimately erased days. He does this until it dons on him that what he truly wants and needs to be is a decent, caring human being, regardless of whether he is ever able to leave Groundhog Day. When he has reached a level of consummate goodness, including being able to reach out to the woman he desires with love instead of exploitation, he is enabled to move forward to the future and leave Groundhog Day.

Has this type of thing ever occurred to you – where you felt stuck in a situation and couldn't seem to move forward no matter what you did? Are you in that type of situation now? Well, then, there's a lesson in *Groundhog Day* for you. Sometimes we're stuck in situations because we're being refined; made into better people, as Phil Connors was. The First Letter of Peter says, "... even if now for a little while you have had to suffer various trials, so that the genuineness of your faith – being more precious than gold that, though perishable, is tested by fire – may be found to result in praise and glory and honor..." (1 Peter 1:6b-7). Paul, in his Letter to the Romans, said, "...we may boast in our sufferings, knowing that suffering produces endurance, and endurance produces character, and character produces hope, and hope does not disappoint us, because God's love has been poured into our hearts through the Holy Spirit that has been given to us." (Romans 5:3-5).

In this cold, dark month of February, ALL of us are at least a little stuck – waiting for more sunshine to come. But no matter what kind of life situation we find ourselves in, the key is not to curse the circumstances; it is to affirm the always positive potential of the Spirit within them. There is always hope. There is always a way forward for those who put their faith in God.

Dear Harrisville Church Family,

While you were hopefully enjoying your week after Christmas, despite the blisteringly cold weather, we had a little conflict within our church family. Apparently, a church member, or members, within our family was upset that, in the days leading up to Christmas, the illuminated sign in front of our church read like this:

XMAS EVE AT F-VILLE 7:30 XMAS DAY 11 AM

I received notice of this on December 28. John McKee, the chair of our Pastor-Parrish Relations Committee, told me that some members of our church thought that the "X" in "Xmas" and the "F" in "F-ville" were inappropriate and should be taken down. I told John that, although the abbreviations were completely appropriate, the sign would be changed later that day to make way for a new message.

Then, a few days later, on December 31, I received a text message from a member of our Church Council. The text was a forwarded message, showing a photo of the aforementioned church sign, with this message underneath it: "... I think this needs to be addressed. Please call me when you get home. Thanks" The message was from Evelyn Baum.

I texted John, asking for a PPRC meeting as soon as possible. We had a meeting on Tuesday, January 3. At the meeting, I made the point that the complaints about the sign were baseless and absurd. I included the following reasons in support of that:

- 1. The abbreviations of "Xmas" and "F-ville" were necessary if we wanted to fit the notice on the sign.
- 2. "Xmas" has been used for centuries as a legitimate abbreviation for "Christmas". "X" is the first letter in the original, ancient Greek word for Christ, which was "Χρίστος". Therefore, "X" has been used in a number of contexts to respectfully and appropriately symbolize "Christ", including in its use in "Xmas". (For further reading on this, please see, for instance, the Wikipedia entry on "Xmas", the Oxford English Dictionary and O'Conner, Patricia T.; Kellerman, Stewart (2009). Origins of the Specious: Myths and Misconceptions of the English Language. New York: Random House. p. 77 among many other works referring to this matter.)

- 3. I couldn't even possibly imagine what could be inappropriate about abbreviating "Forestville" as "F-ville".
- 4. The sign directed people to worship services where they would learn about and worship Jesus Christ, certainly not disregard him.
- 5. To accuse the maker of the sign of the intention of "taking Christ out of Christmas" was personally offensive and defamatory.
- 6. If she was personally confused or concerned about the sign maker's intentions, a simple remedy would have been to ask the sign maker of his intentions.

I proposed, and the committee agreed, that I should meet with Evelyn to discuss and resolve this issue about the sign, with John McKee being present as a witness.

I texted Evelyn the following day, inviting her to discuss the issue with me.

She has refused to meet with me.

And, via a phone conversation with John McKee later that week, Evelyn said she and Carl have decided to leave our congregation.

At a further PPRC meeting on January 12, to address Evelyn's refusal to meet, I proposed, and the committee agreed, that we should provide a statement to the Church Council and then, if approved by the Council, to the congregation, to detail the events described herein, especially to curb the dissemination of misinformation. I was tasked with writing the statement, which, I thought, because it was ultimately to be sent to members of our congregation, should be in the form of a letter. This is that letter.

So we thank Evelyn and Carl Baum for their longtime presence in and service with the Church and we ask you to wish them well and to pray for Evelyn and Carl and their family as they seek connection with the Spirit of God elsewhere.

And Harrisville Church Family? God loves you and so do we. Let us continue to pray for each other and for our congregation. May we continue to seek the joy of Christ wherever he may be found.


"Love one another as I have loved
